ARTWORK REQUIREMENTS:

FILE TYPES ACCEPTED

JPEG, TIF, PSD, AI, EPS, PDF. Unflattened PSD, AI, and EPS

All files must be 300dpi and in CMYK or gray scale colorspace. All fonts must be outlined. All images (photos, etc.) must be embedded or included with the submitted files. If you have multiple ad spaces, you need to submit your ad at each size you are running the ad or additional charges will apply.

TRIM SIZE

Trim size (dimensions) is the final size of your ad when printed in our publication. Unless you choose to run a cover, full page, or half page ad which requires a 0.125" bleed, the size indicated in the "dimensions" column is the size of the file you will submit.

BLEED

Cover, full page and half page ads must include a 0.125" bleed. This will add an additional 0.25" to the height and width of your files trim size (dimensions).

CONTENT / TEXT MARGIN

Files should have 0.25" content / text margin from the edge of your max dimensions to make your text more legible and easier to read and also ensure that your text doesn't get cut off in the case of ads that require a bleed.
